


ND Farm Management Education Program

- Utilize FINPACK to compile year-end balance sheets, profit/loss analysis, enterprise analysis, and look at trends
- Provides a lot of (maybe too much) information
 - Profit/loss
 - Changes in net worth
 - Enterprise analysis



Program Benefits

- Analyze the farm profitability and net worth in two ways.
 - Cost is what the farmer put into the business
 - Market net worth changes based on market conditions (land)
- Participating in the program allows farmers to benchmark operation
 - Whole farm
 - Crop and/or livestock enterprise
- Help farmers make informed decisions






Gross cash farm income




Total cash farm expense




Net cash farm income




Net farm income, accrual




Inventory Change & Depreciation




Assets and Liabilities, cost vs. market




Net Worth & Net Worth Change












Selected Direct Cash Expenses








Govt. Payment as a Percent of Total Expenses




Family Living Expenses & Invest/Capital Purchases
